Union MSME Minister Hon.Narayan Rane launches Union Bank MSME RuPay Credit Card

Union Minister for Micro, Small & Medium Enterprises, Shri Narayan Rane today launched the **Union MSME RuPay Credit Card** of Union Bank of India in Sindhudurg at the two day MSME Conclave being held in the district. The card is being offered by Union Bank of India in association with National Payments Corporation of India (NPCI). It provides a simplified payment mechanism to MSMEs to meet their business-related operational expenses.

The RuPay Card offers benefits like anytime digital payments, interest-free period and will carry interest rate similar to the rate charged for loans. MSME borrowers will be able to enjoy an interest-free credit period of up to 50 days on their business spends. The card also offers the EMI facility to the customers on their business-related purchases. MSMEs will also get specially curated efficient business services on this card which will help them in taking their business on most of the digital platforms.

The RuPay Credit card will simplify and expedite payment mechanism for MSMEs while enabling banks to monitor the transactions at granular level. The Credit card will also reduce the demand for cash withdrawal by the businesses due to availability of the digital payment tool.

Other benefits include accidental insurance coverage, lounge access, and other rewards being offered by NPCI on RuPay cards. Besides this, the card offers variety of additional features and business services for the MSMEs.

During the MSME Conclave, the Union Minister distributed the first batch of RuPay cards to select MSME entrepreneurs.

Comprehensive Handicrafts Cluster Development Scheme (2021-22 to 2025-26)

Introduction:

Integrated projects under CHCDS are intended to scale up the infrastructural and production chain at Handicrafts clusters which have remained unorganized and have not kept pace with the modernization and development that have been taking place so far. Consequently, there has not been any addition of fresh impetus of development and optimum realization of output in the handicrafts sector, which is not only the backbone of long traditional heritage and cultural linkages.

The prospect of this sector lies in infrastructural improvement, modernization of the tools, machinery, process, product development & diversification and creating strong brands. Innovative designs as well as technical know-how, furthered by brand building of the native products hold the key to creating a niche market for the products manufactured by the clusters.

The proposed programme is expected to support the Up gradation/creation of infrastructural facilities coupled with market linkages and product development & diversification. Handicrafts clusters are located in clearly identifiable geographical locations (clusters) that specialize in specific products, with close linkages and inter dependence amongst the key players in the cluster. Further, during implementation of the projects it has been observed that in certain cases interventions are required to be implemented at "various places throughout the country in a particular craft" or "in scattered clusters practicing various crafts in a state/geographical region" for generating employment through skill up-gradation and also for increasing the market base of the craft within the country as well as in the International market. In such cases the CHCD Scheme would be flexible to reach all corners of the country wherever the selected craft exists. The activities may vary from soft to hard interventions. In short, projects under CHCDS can be implemented in a fixed geographical area as well as different places throughout the country in a particular craft or in a state where crafts are identified on block/cluster level. The integrated projects will be taken up for development through Central/State Handicrafts Corporations/autonomous bodycouncil-institute/registered co-operatives/producer company of artisans/registered SPV, having good experience in handicrafts sector as per requirement and as per the DPR prepared for the purpose.



Funding pattern

Funds to the tune of 2% (max.) of project cost up to a maximum of Rs. 5.00 Lakhs (whichever is less) per project shall be earmarked for establishing baseline data / DPR against which performance can be compared at the end of the project. The total fund requirement will be as per the Detailed project Report (DPR). 3% of Total project cost shall be provided for setting up of Project Monitoring Unit (PMU). st nd 50% of the approved project cost will be released as advance/1 instalment. 2 instalment @ 40% of st the approved project cost will be released on utilization of 70% of 1 instalment. The last 10% amount will be released as reimbursement on completion of project and submission of utilization report etc.
