PLI Scheme for Drones

1. The total amount allocated for the PLI scheme for drones and drone components is INR 120 crore spread over three financial years. This amount is nearly double the combined turnover of all domestic drone manufacturers in FY 2020-21.
2. The incentive for a manufacturer of drones and drone components shall be as high as 20% of the value addition made by her.
3. The value addition shall be calculated as the annual sales revenue from drones and drone components (net of GST) minus the purchase cost (net of GST) of drone and drone components.
4. The Government, has agreed to keep the PLI rate constant at 20% for all three years, an exceptional treatment given only to the drone industry. In PLI schemes for other sectors, the PLI rate reduces every year.
5. The proposed tenure of the PLI scheme is three years starting in FY 2021-22. The PLI scheme will be extended or redrafted after studying its impact in consultation with the industry.
6. The Government has agreed to fix the minimum value addition norm at 40% of net sales for drones and drone components instead of 50%, another exceptional treatment given to the drone industry. This will allow widening the number of beneficiaries.

7. The PLI scheme covers a wide variety of drone components:

- a. Airframe, propulsion systems (engine and electric), power systems, batteries and associated components, launch and recovery systems;
- b. Inertial Measurement Unit, Inertial Navigation System, flight control module, ground control station and associated components;
- c. Communications systems (radio frequency, transponders, satellite-based etc.)
- d. Cameras, sensors, spraying systems and related payload etc.;
- e. 'Detect and Avoid' system, emergency recovery system, trackers etc. and other components critical for safety and security.
- f. The list of eligible components may be expanded by the Government from time to time, as the drone technology evolves.
- g. The Government has agreed to widen the coverage of the incentive scheme to include developers of drone-related IT products also.
- h. The Government has kept the eligibility norm for MSME and startups in terms of annual sales turnover at a nominal level - INR 2 cr (for drones) and INR 50 lakhs (for drone components). This will allow widening the number of beneficiaries.
- i. Eligibility norm for non-MSME companies in terms of annual sales turnover has been kept at INR 4 crore (for drones) and INR 1 crore (for drone components).

The incentive payable to a manufacturer of drones and drone components shall be simply one-fifth of her value addition as illustrated below for a sample year (say, FY 2021-22):

Exports rises 21% to USD 23.7 bn during May 1-21

The country's exports rose by 21.1 per cent to **USD 23.7** billion during May 1-21, on account of healthy growth in various sectors, such as petroleum products, engineering, and electronic goods, an official said. During the second week of this month (May 15-21), the exports grew by about 24 per cent to **USD 8.03 billion**, the official added.

Petroleum products, engineering, and electronic goods' exports during May 1-21 expanded by 81.1 per cent, about 17 per cent and about 44 per cent, respectively. The total figure for May is likely to be realised by the commerce ministry in June.



PM Modi invites US industries to partner with India to to manufacture in defence sector under Make in India and Atmanirbhar Bharat programmes

OKYO: Prime Minister Narendra Modi on Tuesday extended a warm and strong invitation to American companies to participate in co-development, co-design and co-manufacture under the Make in India and the Atmanirbhar Bharat programmes under the rubrics of defence. Prime Minister Modi extended the invitation to the US industries during the productive talks he had with US Joe Biden on the sidelines of the Quad summit in Tokyo.

"The question of India-US defence partnership did come up in discussions between Prime Minister Modi and President

Biden. But it was very clear the focus of the discussion was on defence manufacturing by the American companies in India under the framework of Make in India and Atmanirbhar Bharat," Foreign Secretary Vinay Kwatra said during a media briefing here "Prime Minister Modi extended a warm and a strong invitation to the US industry to come to India to participate in the co-development, co-design and co-manufacture, even absolute manufacturing under the Make in India and Atmanirbhar Bharat.

The focus was on defence manufacturing in India under the rubrics of defence," he said while responding to a question whether the Biden administration has offered a \$500 million aid package.

It was reported by a Western media outlet that the package under consideration would include foreign military financing of as much as \$500 million to wean off India from purchasing military equipment from Russia.

he report said that if deal works out, it would make India one of the largest recipients of such aid behind Israel and Egypt.

It's unclear when the deal would be announced, or what weapons would be included.



शेतकऱ्यांनो उद्योजक व्हा.....!

स्थापन करा शेतकरी उत्पादक कंपनी आणि उद्योजक व्हा, जागतिक बँक आणि महाराष्ट्र सरकारने केला मदतीचा हात पुढे

शेतमालाला भाव नाही आणि शेतकऱ्यांच्या वाढणाऱ्या आत्महत्या अशा बातम्यांचा काळ आता लवकरच संपुष्टात येण्याची चिन्हे आहेत. शेतीमालाची उत्पादकता आणि बाजारमूल्यांची सांगड घालून नफा कमावण्याचे दिवस आता फार लांब राहिलेले नाहीत, कारण शेतकरीच आता उद्योजक बनणार आहेत !

शेतीला उद्योगाचा दर्जा मिळावा म्हणून आस लावून बसलेल्या शेतकऱ्यांना आता जागतिक बँक आणि महाराष्ट्र सरकारच्या मदतीने स्वतःच उद्योजक बनण्याचा मार्ग सापडलेला आहे, राज्यातील शेतकरी गटांचे रूपांतर कंपन्यांमध्ये करण्यात येत असून, बाजाराभिमुख व्यवस्थापनासाठी शेतकरी उत्पादक कंपन्याची स्थापना करण्यात येत आहेत. येत्या मार्च पर्यंत महाराष्ट्रातील सर्व जिल्ह्यांमध्ये शेतकरी उत्पादक कंपन्या स्थापन्याचे उद्दिष्ट ठेवण्यात आले आहे.

जागतिक बँक आणि महाराष्ट्र सरकारच्या अर्थसहाय्यातून स्मार्ट (SMART) प्रकल्प राबविण्यात येणार आहे. राज्यातील १० हजार गावांमध्ये स्टेट ऑफ महाराष्ट्र अॅग्रीबिझनेस अॅण्ड रुरल ट्रान्सफॉर्मेशन (स्मार्ट) (SMART) ही महत्वाकांक्षी योजना सुरु करण्यात येणार आहे. २३०० कोटी रुपये खर्चाची ही योजना असेल, तिचा ७० टक्के आर्थिक भार जागतिक बँक तर ३० टक्के भार राज्य सरकार उचलणार आहे.

• काय आहे (स्मार्ट) (SMART) योजना?

या योजने अंतर्गत शेतकरी उत्पादक कंपन्या, महिला बचत गट, प्राथमिक कृषी पतसंस्था, शासनाच्या व्हिलेज ट्रान्सफॉर्मेशन आर्दीकडून स्थानिक पातळीवर प्रक्रिया केलेला कृषी माल बड्या कंपन्या खरेदी करणार आहेत. शेतमाल थेट गावातून विकला जावा, गावागावात शेतकऱ्यांचे प्रक्रिया उद्योग उभे राहावेत, हा या योजनेमागचा उद्देश आहे.

या प्रकल्पाचा जास्तीत जास्त लाभ मिळवण्यासाठी शेतकऱ्यांनी आपापल्या गावांमध्ये शेतकरी उत्पादक कंपन्या स्थापन करणे गरजेचे आहे.

• शेतकरी उत्पादक कंपनी म्हणजे काय?

शेतकरी उत्पादक कंपनी (एफपीसी) हे कंपनीचे कायदेशीर स्वरूप आहे आणि हि कंपनी कायदा १९६६ व २०१३ नुसार नोंदणी होते. शेतकरी उत्पादक कंपनी अशी एक संस्था आहे ज्यामध्ये कायदानुसार केवळ शेतकरी हेच या कंपनीचे सदस्य असू शकतात आणि शेतकरी सदस्य स्वतःच या कंपनीचे व्यवस्थापन करतात.

शेतकरी उत्पादक कंपनीच्या संकल्पनेमध्ये उत्पादक, खासकरून लहान आणि किरकोळ शेतकऱ्यांचे संकलन समाविष्ट आहे जेणेकरून शेतीतील अनेक आव्हाने एकत्रितपणे गुंतवून ठेवण्यासाठी एक प्रभावी गठबंधन तयार करणे, जसे की गुंतवणूक, तंत्रज्ञान, इनपुट आणि बाजारपेठेत सुधारित प्रवेश, शेती पिकांचे उत्पादन, कापणी, खरेदी, ग्रेडिंग, पूलिंग, हाताळणी, विपणन, विक्री, सदस्यांचे प्राथमिक उत्पादन निर्यात करणे किंवा वस्तू किंवा सेवा आयात करणे यासाठी अस्तित्वात येते.

सामूहिकरीत्या शेतीचे उत्पादन आणि उत्पादकता वाढविणे, तसेच बाजार संपर्क व शेतमालाच्या थेट विक्रीतून शेतकऱ्यांना नफा मिळू शकतो.

शेतकरी कंपनीमार्फत कृषीआधारित विविध व्यवसाय सुरु करण्यात येतात यातून मिळणारा नफा व लाभांश शेतकरी सभासदांना विभागून मिळू शकतो.

• अशी स्थापन करता येते शेतकरी उत्पादक कंपनी:

गावपातळीवरील १० शेतकरी किंवा शेतकरी गट एकत्र येऊन शेतकरी उत्पादक कंपनी स्थापन करू शकतात तसेच एकापेक्षा जास्त गावे मिळून देखील शेतकरी उत्पादन कंपनी स्थापन केली जाऊ शकते. या कंपन्यांची मिनिस्ट्री ऑफ कॉर्पोरेट अफेअर्स या डिपार्टमेंट कडे कंपनी कायदा १९६६ अंतर्गत नोंदणी केली जाते.

• शेतकरी उत्पादक कंपन्यांना मिळणारे विविध फायदे आणि योजना:

• शेतकरी उत्पादक कंपनीची नोंदणी झाल्यापासून पुढील ५ वर्ष तिच्या नफ्यावर कोणताही कर भरावा लागणार नाही

• सन २०१८-१९ च्या बजेट मध्ये सरकारने ऑपरेशन ग्रीनला मंजुरी दिलेली आहे.

• सन २०१८-१९ च्या बजेट मध्ये शेतकरी उत्पादक कंपन्यांसाठी ५०० कोटी रुपयांचीची तरतूद केलेली आहे.

• शेतकरी उत्पादक कंपन्यांना जास्तीत जास्त कर्ज मिळण्यामध्ये सुलभता मिळते.

• नाबार्ड कडून सवलतीच्या दारात कर्ज उपलब्ध होते तसेच विविध प्रकल्पांना अनुदान दिले जाते.

• नाबार्ड च्या प्रोड्युसर ऑर्गनायजेशन डेव्हलपमेंट फंड (PODF) तर्फे विविध प्रकारचे कर्ज उपलब्ध करून दिले जाते.

• कर्जावरील व्याज दर दुसऱ्या कंपन्यांच्या तुलनेत कमी असतो.

• सहकारी संस्थाना दिल्या जाणाऱ्या विविध योजना आता शेतकरी उत्पादक कंपन्यांना सुद्धा दिल्या जाणार आहेत.

• समूह शेती तसेच समूह शेतीला लागणारे तंत्रज्ञान सरकार अगदी सुलभतेने उपलब्ध करून दिले जाणार आहे.

• **इक्विटी ग्रॅन्ट योजना:** = SAFC, Delhi या संस्थेकडून शेतकरी उत्पादक कंपन्यांना १५ लाख रुपये पर्यंत इक्विटी ग्रॅन्ट दिली जाते.

• क्रेडिट ग्यारंटी फंड: SAFC, Delhi या संस्थेकडून शेतकरी उत्पादक कंपन्यांना त्यांच्या प्रोजेक्टच्या ८५% किंवा जास्तीत जास्त १ करोड रुपयापर्यंत कमी व्याज दराने कर्ज दिले जाते.

• अवजारे बँका: महाराष्ट्र राज्यात अनेक अवजारे बँका सुरु झालेल्या असून त्यामधून शेतकऱ्यांना व शेतकरी उत्पादक कंपन्यांना विविध प्रकारची अवजारे आणि यंत्र सामग्री भाडे तत्वावर आणि सुलभ हप्ताने दिली जाणार आहेत.

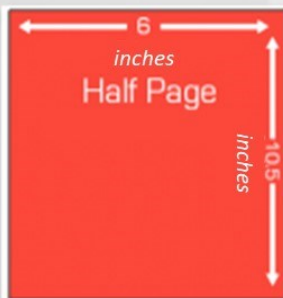
